

## RFI RESPONSE

Marlisa Bustos w/ United Paving, Dated April 15 2022

- Q1. Is contractor responsible to re-seed any landscaping that may driven over with our equipment? If so, what is the seed requirements?
- A1. Yes, plan to smooth out ruts caused by machines, and please see the attachment labeled seed Grass seed spec.
- Q2. The redwood header spec calls for 2x8, however on the map it shows 2x6. Can you please confirm??
- A2. Everything will be 2x8 for all headers throughout the project.
- Q3. Will the school move the storage bins that are currently onsite?
- A3. Yes, the District will move the containers.
- Q4. Who is responsible for the weed kill prior to crack seal?
- A4. The contractor, no products containing glyphosate.
- Q5. Regarding the cracks that are over 1", will you require the contractor to grind 18" and pave?
- A5. No, grind just fill with asphalt and roll flat.
- Q6. The plans call for "asphalt grindings"... Will we dump all grindings onsite? Do we need to roll the grindings?
- A6. Yes, the contractor will dump and spread to roughly 3"-4" depth. No rolling is necessary.
- Q7. Can the school provide the quantities for this project? Without quantities the bid will not be apples to apples, thus making it difficult for a competitive bid.
- A7. Assuming this is in regards to the asphalt grindings, its 14,648 square feet by roughly 3"-4" thick.
- Q8. The seal coat spec calls for a total of 60 gallons to be used.. Is this correct?
- A8. 60 gallons per 1,000 square feet area.
- Q9. Do we need a certified engineer to survey the project? Are the grades going to change?
- A9. No to both.
- Q10. Are we relocating the utilities? Who will be responsible for this?
- A10. No.
- Q11. Will we have the entire site to ourselves or would we need to consider several phases?

- A11. Carlton oaks will have another contractor onsite. However, they will be out of the contractors way.
- Q12. Does the school have a budget for this project? I see that it's estimated at \$200,000-\$500,000, however looking at the scope and taking into consideration the dump fees for the clay base it may be a \$800,000+ project.
- A12. No.
- Q13. Can we install the redwood header 1' away from the fence?
- A13. Yes.
- Q14. If the school does not provide quantities, can the contractor go to the sites and field measure for verification?
- A14. Yes.
- Q15. Will we replace the AC berm?
- A15. Only along the south side of the campus indicated by pink arrows.
- Q16. Can you please clarify "extend DG area"?
- A16. Demo existing asphalt to native soil and from tetherball pole to the northeast side of the bench. See video for more information.
- Q17. Does the school want us to price per the soils recommendations? It seems the map reflects the recommendations.
- A17. Yes, price should reflect the recommendations of the soils report.
