A. CALL TO ORDER

The meeting was called to order at 7:19 p.m. by President Ryan.

B. CLOSED SESSION

1. Discipline Hearings for Student #77 (Pursuant to Education Code 48918)

After oral and documentary evidence was received, President Ryan announced that the Board members would deliberate and all other persons were asked to leave the room. Board deliberations are not tape recorded.

C. RECONVENE TO PUBLIC SESSION

1. Student Discipline Case #77

It was motioned to not expel student # 77 from the Santee School District for violations of California Education Code Sections 48900 (c), (j) and (k), and the student shall complete the following elements in a Rehabilitation Plan:

- The student may return to previous school after the Rehabilitation Plan has been signed.
- The student will maintain 2.0 GPA for academic and citizenship performance.
- The student will receive no new suspensions.
- The student will attend school regularly with no unexcused absences or tardies.
- The student will adhere to a student behavior plan developed by school administration.
- The student will perform 10 hours of community service.
- The student shall complete a counseling program by October 6, 2003, for drug abuse prevention and/or treatment.
- The student shall remain free of illegal substances and participate in a drug testing program.
- The parents will provide parental permission for the District to access and share confidential student information.
- Complete all elements of this Rehabilitation Plan by October 15, 2003, and present documentation to verify completion.

The parent must meet with the Director of Pupil Services by June 4, 2003, to review and sign the Rehabilitation Plan. If the parent fails to meet within the designated time and/or does not sign the Rehabilitation Plan, the student may be referred to the Board of Education for consideration of expulsion.
