B. PUBLIC COMMUNICATION

C. SCHOOL SITE CONSTRUCTION TOURS OF PHASE I SCHOOOLS

The Board of Education toured the Phase I Schools (Rio Seco, Cajon Park, Carlton Hills, Carlton Oaks, and Sycamore Canyon) to see the modernization and construction completed during the summer months. The Board discussed post occupancy items and colors and finishes for benches, doors, concrete, lockers, and the junior high buildings in Phase I and Phase II.

D. <u>DISCUSSION AND SELECTION OF COLOR OPTIONS</u>

Following the school site tours, Board members discussed and selected color/finish and aesthetic options for benches, doors, concrete stain, PE lockers, future additions, and Phase II schools. Board members agreed to the following:

- 1. Junior High Concrete Stain: Terra Cotta Brown for the stair landing at Caion Park
- 2. Bench Colors: The Board decided to place blue benches at the blue Phase I schools, Cajon Park, Carlton Hills, Carlton Oaks, and Sycamore Canyon. Cranberry benches will be installed at Rio Seco, which is a red school. The Board requested administration to use as many of the 16 cranberry benches at Rio Seco as is reasonable and to continue to store the rest for Phase II schools.

For Phase II schools, the Board decided to wait and see the installed benches at Rio sand then make a decision as to blue, tan or red benches at those schools.

 Doors: Member Ryan moved to have brown doors for the new junior high building at Cajon Park. Member Carlisle seconded.

 PE lockers: The Board designated administration to determine how to alternate the gray and blue colors on the walls in the locker rooms. The boys PE lockers will be blue and the girls PE lockers will be burgundy

Christina Becker showed the Board the location of the trees in the back by the round buildings at Rio Seco and Carlton Oaks that are required to be removed due to compliance issues with the adjacent buildings due to access codes.
